#### **Codes of Practice**

**Bison** – the Code Development Committee met in September. A summary of the meeting will soon be available at <u>www.nfacc.</u> <u>ca/progress-report-bison</u>.

**Chickens, Turkeys and Breeders** – the draft Code of Practice for the Care and Handling of Hatching Eggs, Breeders, Chickens and Turkeys has reached a milestone, it will be released for public comment on October 5, 2015. The public comment period closes December 4, 2015. Watch for a press release announcing the start of the public comment period on the morning of October 5.
